The 23rd Annual Community Trash Off for Orange, Texas and surrounding communities will take place **Saturday, February 24, 2018, from 8:00 a.m. to 1:00 p.m.** at the City of Orange Boat Ramp located on Simmons Drive. The Community Trash Off is organized by the staff of Shangri La Botanical Gardens and Nature Center and conducted by volunteers from Orange, West Orange, Pinehurst and other surrounding communities.

Any individual, group, or business interested in registering a team should complete this form and email it to Jeremy Whipple at jwhipple@shangrilagardens.org. Volunteers of all ages are encouraged, but please note that groups must have a minimum ratio of 1 adult to 4 children (ages 18 and younger).

Teams will be assigned to clean-up a designated station in Orange, West Orange, or Pinehurst. If you have a preference for a particular station or area, you are encouraged to register early, as stations will be assigned on a first-come, first-served basis. Any volunteers who have and are willing to bring their small boats for clean up along Adams Bayou and/or the Sabine River are especially sought. Please consider this as an option in indicating your preferred volunteer location.

Stations will be assigned upon receipt of this application. On the day of the Trash Off, groups are encouraged to report directly to their assigned stations.

Duties of a Team Leader

Arrive at the City of Orange Boat Ramp on Simmons Drive by 7:30 a.m. on Saturday, February 24, 2018, to pick up equipment and supplies (garbage bags, gloves, etc), and to sign in your team. If your entire team is reporting directly to its assigned station, you will then go to meet them there.

Collect litter in, on and around your assigned station and supervise the safety of your team. *Safety should be a team's first priority. Each team is responsible for its own activities and the manner in which it conducts any operations relating to the Trash-Off; participation in the Trash-Off is at the participant's own risk and event sponsors and organizers are NOT responsible for any injuries or damaged property that may arise or result from any individual's participation in the Trash-Off event.*

Each adult team member and responsible adult of a minor team member must complete a Waiver Form. Waiver Forms are available as part of the Registration Form and will also be available at the event. Multiple Waiver Forms may be completed on one sheet and submitted with the Registration Form.

If you have an appropriate vehicle, please load and deliver all bags of collected trash to the City of Orange Boat Ramp upon completion of your area. Return to the Boat Ramp by 11:30 a.m. for pizza and fellowship. Upon your return, please sign in your team and return all equipment and supplies. If you have any questions, please call 409.670.0803.
